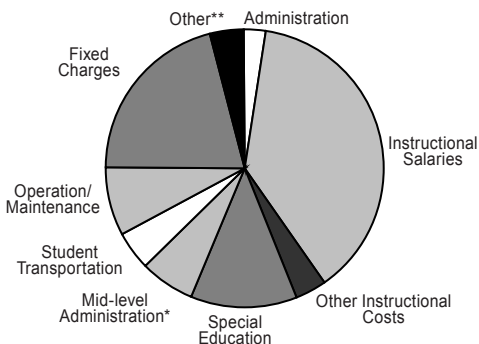

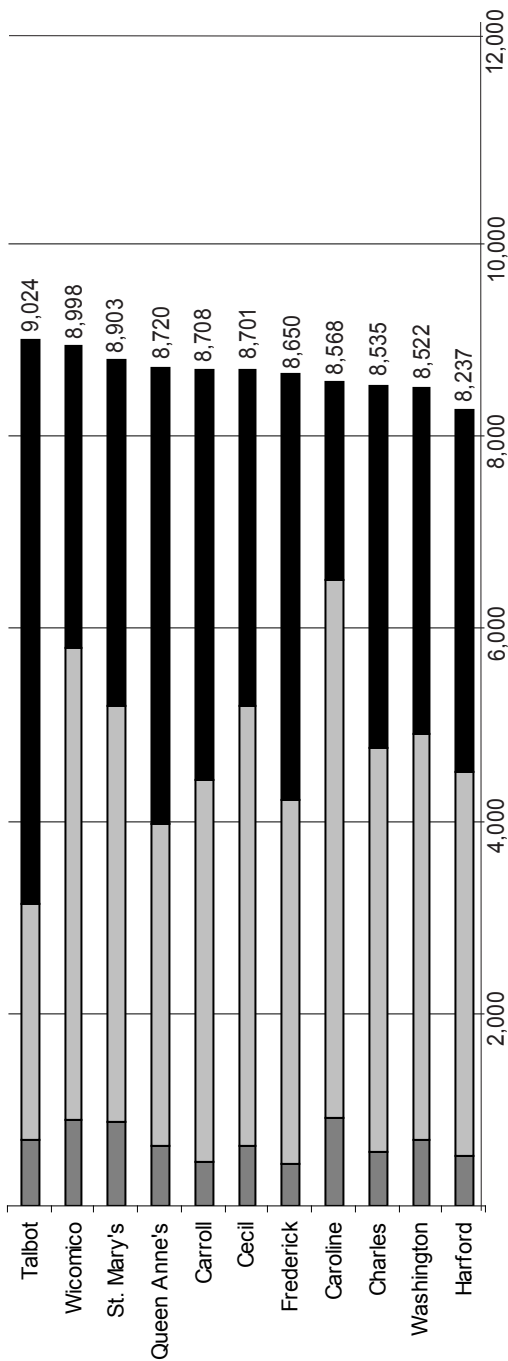

Cost per Pupil Belonging* Maryland Public Schools: FY 2005

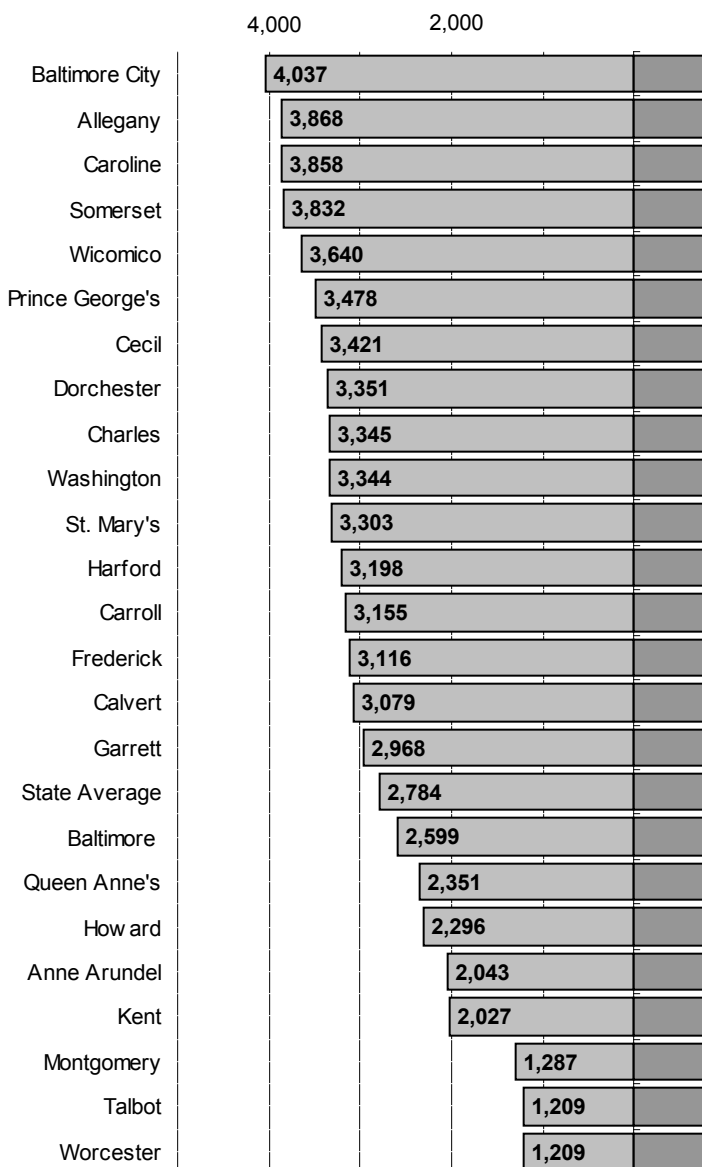

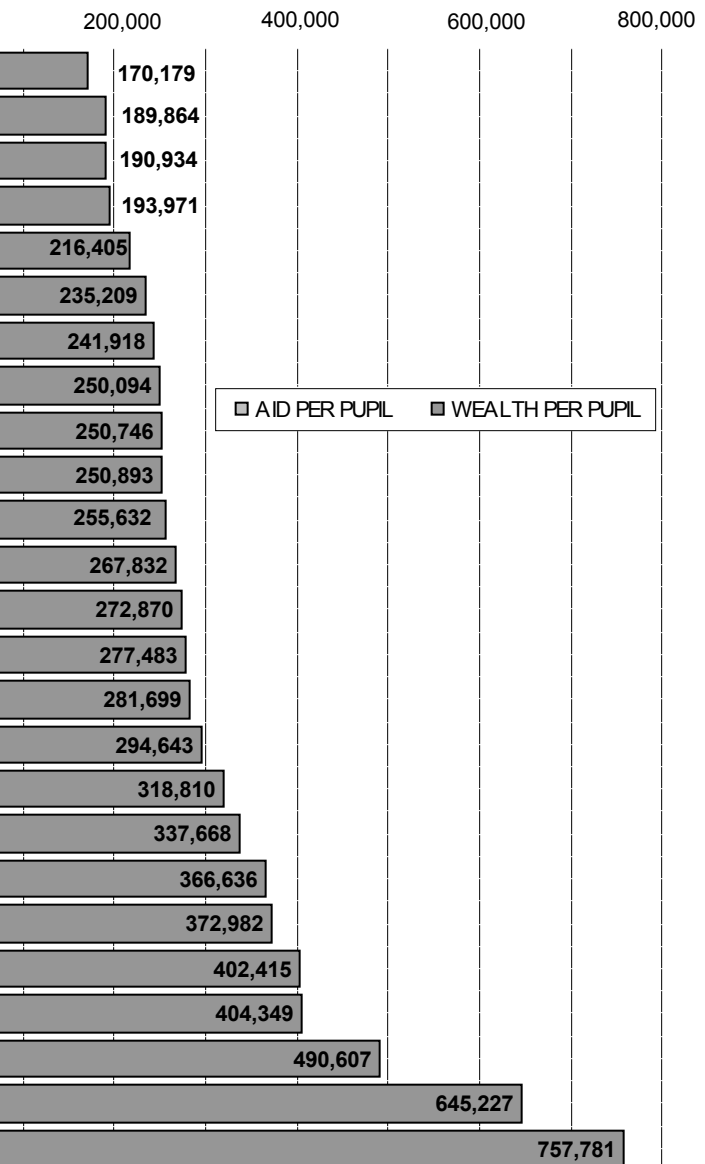

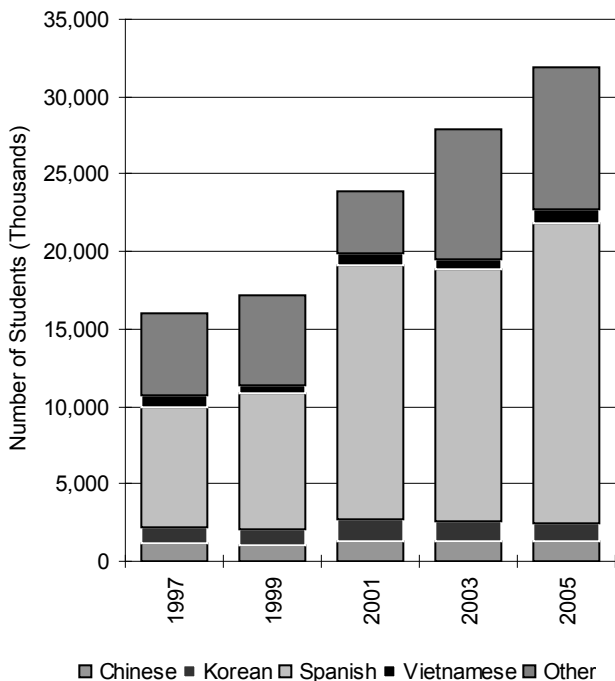

Education Superlatives

- For the sixth consecutive year, *Education Week* has given Maryland an “A” for its K-12 standards and system of student testing and school accountability.
- The number of students taking at least one AP exam increased 11.7% in 2006. Since 2002, the number of students taking an AP exam jumped 66.9%; the number of exams taken jumped 70.6%, and the number of exams scoring 3-5 jumped 55.6% (The College Board).
- Maryland’s compliance with the No Child Left Behind Act earned high marks in 58 areas, including reporting and accountability, standards-based curriculum, outreach to schools and the public, and efforts to improve teacher preparation and professional development (MGT of America).
- Last year, Maryland ranked second in the nation in the percentage of graduating seniors who scored 3-5 on at least one AP exam. Maryland posted the nation’s largest five-year improvement on that AP indicator (The College Board).
- Maryland is one of three jurisdictions to have closed the Latino AP participation gap (The College Board).
- For the third consecutive year, Maryland School Assessment scores have risen in each of Maryland’s 24 school systems and in each grade assessed.
- High school Assessment scores rose dramatically in 2006. The share of students passing the algebra exam climbed from 53.8% in 2005 to 66.6% in 2006; the share passing biology climbed from 57.6% to 67.8%; and the share passing government climbed from 66.4% to 74.2%
- Maryland’s SAT scores remain the highest in the Mid-Atlantic region, according to the College Board. Maryland’s combined score of 1511 ranked Maryland fourth among all states with a 70% or better participation rate in the exam.
- Maryland ranked first in the nation for improving the number of students participating in Summer Nutrition programs from 2004 to 2005, a 22.9% increase. In 2005, 44 sponsors of the MSDE-administered U.S.D.A. Summer Food Service Program served more than 670,000 breakfasts and 1.06 million lunches to children throughout Maryland.
- Maryland students raised \$1.4 million to aid the victims of Hurricane Katrina. Maryland Kids Care, the largest charitable fundraising campaign in Maryland public school history, has become the model for other states’ fundraising efforts.

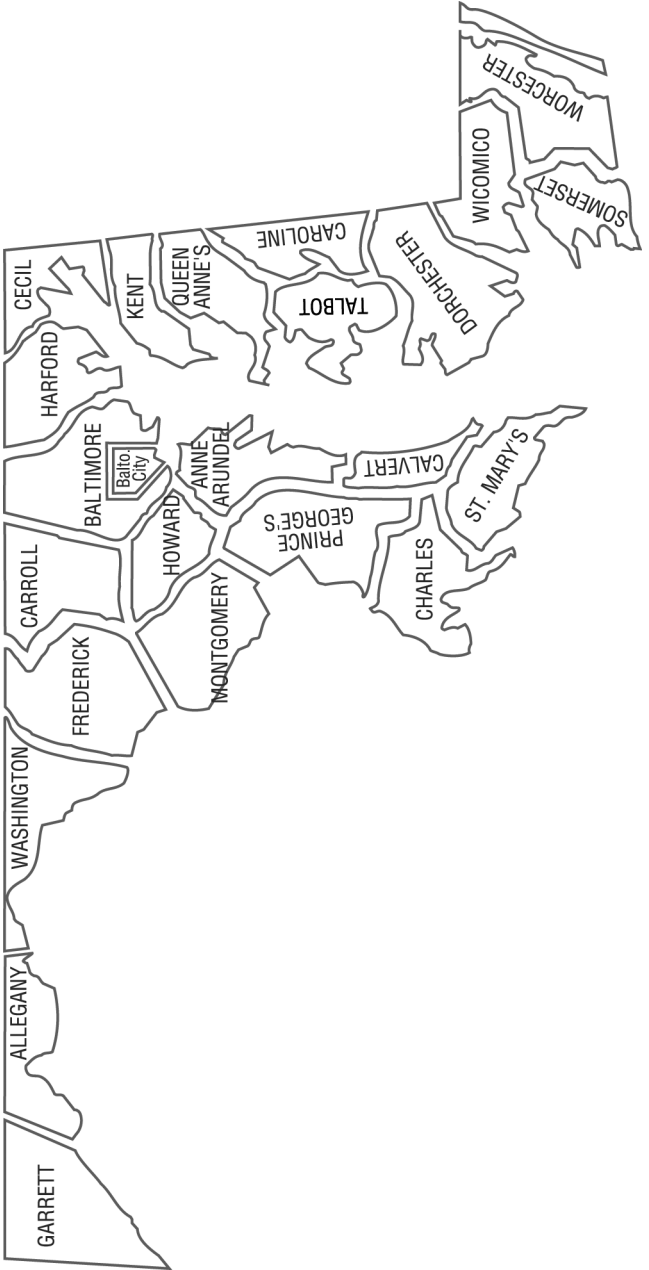
